

Al Policy

PPP recognises the value of artificial intelligence (AI), when used responsibly, to help authors in the research and writing process. Despite the potential of AI and AI-assisted technologies, these tools must never be used as a substitute for human thinking and expertise. Authors are ultimately responsible for the content of their work.

Understanding the different tools

- Assistive Al: These tools refine your own work without creating new content. For example, tools like Microsoft Word will flag spelling and grammar errors, make suggestions for the next word/phrase and suggest better phrasing for increased clarity.
- Generative Al: These tools create new content (text, ideas, images, code) in response to a prompt, for example, tools such as ChatGPT, DALL-E and Copilot. It is important to note that even if you made significant changes to the content, if the Al tool was the primary creator, it would still be Al-generated.

It is important to be aware of the tool you are using because some contain both Assistive and Generative features. You are responsible for knowing which feature you are using and be sure to adhere to PPP policy.

For Authors

 Al assistance: Al tools that make suggestions to improve or enhance your own work, such as tools to improve language, grammar or structure do not require disclosure by authors or reviewers.

Generative AI:

- It is important that you do not use AI to generate an article and then submit it as your own work.
- We do not permit the use of AI to create or alter images in any submissions (this
 does not include adjustments to things like brightness and contrast as long as
 the original information is presented).
- Authors must state how AI has been used if it has been used in any way in the preparation of their paper (see Disclosure heading).
- You should never acknowledge Al as a co-author, because Al cannot meet the requirements for authorship or take responsibility for the work.

Disclosure

If Generative AI has been used in the preparation of the paper, a separate AI declaration statement should be included within your manuscript upon submission. This should include the name of the AI tool used and the purpose of the use. This should be clearly described to ensure transparency and referenced appropriately.

If Al has been used in the research process, this should be declared and described in detail in the methods section, rather than in the disclosure statement.

Remember that you do not need to declare the use of Assistive Al.

For Reviewers

- Al assistance: Al tools maybe used to improve the quality of the language of your review, but you are responsible for accuracy and content of your review.
- **Generative AI:** As a reviewer, you are expected to treat the document as confidential. You must not upload a submitted manuscript or any part of it to a Generative AI tool as this violates the authors' rights. This applies also to the reviewers comments/report, as it may contain confidential information about the paper.

If at any point, reviewers suspect the inappropriate or undisclosed use of Generative AI in a submission they should flag their concerns with the PPP Editors. This will be investigated and note that editors reserve the right to withdraw the paper from the submission and review process.

For Editors

- Al assistance: Al tools maybe used to improve the quality of the language of any correspondence with authors and reviewers, but you are responsible for accuracy and content of your review.
- Generative Al: As an Editor, you are expected to treat the document as confidential.
 You must not upload a submitted manuscript or any part of it to a Generative Al tool as this violates the authors' rights.
